And Waiver and Release of Liability

The undersigned hereby acknowledge that The Citadel sponsors, controls and is responsible only for the educational content and instruction
of the Study Abroad programs. The undersigned further acknowledge and understand that reservations, schedules, itineraries, rates, charges
and other accommodations are based on information provided to The Citadel and that The Citadel is not responsible or liable to the undersigned
for the accuracy or reliability of such information or activities connected therewith such as travel, lodging, meals, customs, immigration,
government regulations, and tariffs charges or rates related to such activities or items. The undersigned further acknowledge and agree that
The Citadel has no responsibility to the undersigned for passports, visas, international travel permission, or other medical care or preventatives,
and the undersigned assume the sole and full responsibility and liability for any such matters.

The undersigned further acknowledge and understand that the student may encounter various risks, both known and unknown, from events
and activities of such participation and foreign travel, specifically including but not limited to commercial transportation, lodging, international
and foreign travel, domestic and foreign government restrictions and regulations, acts of God, strikes, insurrection or war, riots illness, currency
exchange rates, tariffs, customs, immigration and other events or activities. The undersigned specifically accept and agree that The Citadel is
not liable for any injury, damage or harm resulting from any such risk, event or activity. The undersigned further hereby specifically release
and forever discharge The Citadel and its officers, faculty, employees, insurers, agents and representatives from any liability for any injury,
damage, harm, expense, or other loss to the undersigned resulting from any cause whatsoever other than the educational content and instruction
of the Study Abroad program; and the undersigned assuming the full and sole responsibility for all such risks and intentionally waiving any
rights the undersigned have or may have against The Citadel or its officers, faculty, employees, insurers, agents or representatives as a result
thereof. This release of liability is not intended to be and is not a release or waiver of any claims against any other person or entity for any
injuries, damages, harm, expense or loss which the undersigned may sustain or incur, the undersigned specifically reserving all rights against
any other person or entity not named herein.

The undersigned further agree to reimburse and hold harmless The Citadel for any financial liability or obligation for injury or damage to
the person or property of others caused by the undersigned; and the undersigned further acknowledge and agree that The Citadel has full
authority to terminate the student's participation in the Study Abroad program for any failure on the student to comply with the rules, standards,
and instructions of The Citadel relating to the Study Abroad program with no refund of fees, and that in such event the student may be sent
home at the expense of the undersigned.

The undersigned further grant to The Citadel, at its discretion, to place the student, at the undersigned's expense in a hospital at any point for
any service or treatment, or, if it deems necessary or advisable, to place the student in the hands of a local doctor for treatment. The Citadel is
further authorized to have the student returned to the United States at the undersigned's expense for medical treatment if deemed necessary or
advisable by The Citadel in consultation with local medical authorities.

The undersigned further acknowledge and agree that The Citadel has no responsibility or liability to any person for any injury, damage,
harm, expense, liability, or cost including specifically any adverse effect on health or physical well-being of the student in the event the student
travels abroad or within the United States before the beginning or after the end of the Study Abroad program, and the undersigned further
release and discharge in full The Citadel and its officers, faculty, employees, insurers, agents, and representatives from any and all
responsibility or liability of any kind or nature resulting therefrom.
